2018 SPONSORSHIP AGREEMENT Terms & Conditions

- 1. This Agreement shall be binding upon its acceptance as set forth on page 1 and per the terms listed below.
- 2. The ("Sponsor") hereby submits the signed agreement ("Agreement") for Sponsorship at the 2018 Annual Convention & Exhibition (ACE) of the American Association of Petroleum Geologists, a corporation ("AAPG") to be held 20-23 May 2018 at the Salt Palace Convention Center in Salt Lake City, Utah.
- 3. Sponsorships are non-refundable and non-transferable.
- 4. All Sponsorship amounts are listed in U.S. dollars and must be paid in U.S. dollars.
- 5. Sponsorship monies paid to AAPG may be deductible as ordinary and necessary business expenses. They are not deductible as contributions or gifts for U.S. federal income tax purposes. AAPG is a 501(c)(6) membership organization; sponsorships paid to AAPG are not charitable donations.
