# HONORS AND AWARDS PROGRAM

t is a characteristic of professional scientists that they take great pride in their achievements. Although recognition of an individual's accomplishments may take many forms, to be honored by one's peers may be the most satisfying of all.

The Honors and Awards program of AAPG provides a means for recognizing outstanding achievements and contributions by professional geologists, especially in the area of exploration for petroleum and energy mineral resources, and by other professionals who further the goals and objectives of our science, our profession, and our Association. The motivation toward scientific and professional achievement which such recognition stimulates is much to be desired.

The continued success of this program is dependent on the identification of those worthy of recognition. As the Association has grown, so have the number of awards and the purposes for which they are given. It is no longer possible for one small central committee to identify all those who should be considered. This is particularly true in the case of awards that are given in recognition of accomplishments that may not be widely known, or are not restricted to Association members - such as Grover E. Murray Distinguished Educator Award and Geosciences in the Media Award. It is necessary that the assistance of the Affiliated Societies, Sections, Divisions, and Associated Societies be enlisted. It is for this reason that this summary of the Association's Honors and Awards has been prepared, describing the purposes of the awards as well as the requirements and the manner in which various organizations and individuals can, and should, identify and nominate (with appropriate documentation) those they feel deserve recognition.

To accomplish these objectives, it may be advisable for Affiliated Societies, Sections, Divisions, and Associated Societies to organize, by committees or other means, a monitoring of those activities for which awards should be considered, especially for the Michel T. Halbouty Outstanding Leadership, Geosciences in the Media, and Public Service awards. For a listing of past awardees, please refer to the Annual Report issue of the Bulletin, also located on the AAPG Web site at http://www.aapg.org under "Honors and Awards." Nominations by individuals will be considered but obviously those by organizations carry the most weight, especially when supplemented by individual support.

The Executive Committee, acting on a recommendation from the Advisory Council, requests that nominees not be publicized and that this information be kept confidential until after selections have been made and approved by the Executive Committee.

### SIDNEY POWERS MEMORIAL AWARD

he Sidney Powers Memorial Award is given in recognition of distinguished and outstanding contributions to, or achievements in, petroleum geology. It is AAPG's most distinguished award, and is made at such times as the Executive Committee may designate, but not more than once in any calendar year.

#### Restrictions

The recipient must be a Member of the Association. A candidate must be living at the time of selection and willing to be present to receive the medal and certificate at the time and place designated by the Executive Committee, normally at the Annual Convention.

# Guidelines for Consideration of Candidates

Consideration should emphasize contributions to petroleum geology - not necessarily service to the Association. Contributions may have been in a variety of forms or combinations, such as a significant development in geologic concepts, advancement in discovery thinking, leadership in exploration and the development of explorationists, inspiration and academic preparation of petroleum geologists, etc. Publication is not a necessary criterion; it is recognized that in today's competitive world, publication may not be feasible for many very able explorationists. Honorary Membership is not a prerequisite for consideration, but it may serve as a useful checklist for potential candidates.

#### Procedure for Recommendation

Nominations for this award should be submitted, along with documentation, to the Chairman of the Honors and Awards Committee at Association Headquarters. The Committee's recommendations will be submitted to the Advisory Council, which in turn will submit its selection to the Executive Committee for final action.

# **Description of Award**

The gold plated medal features a bas-relief likeness of Sidney Powers and the name of the Association on the obverse side. On the reverse side are inscribed the words, "Awarded for Distinguished Achievement in Petroleum Geology," along with the name of the recipient. The medal is mounted in multi-sided acrylic and is presented along with an embossed certificate and a lapel pin tack. Honorary Membership is automatically bestowed upon recipients of the Sidney Powers Memorial Award, if they have not already received that honor.

### History

The Powers Medal was first awarded in 1945 to Wallace E. Pratt.

Sidney Powers was a founding member and 14th President of the Association. He died in 1932 at the age of 42. Frank R. Clark, in his memorial to Sidney Powers said, "Sidney Powers will be known by future generations for his able contributions to pure and applied geology, but, important as are his scientific achievements, his character was greater, because it typified service to others."

# **Funding**

The AAPG provides funding for the Sidney Powers Memorial Award.

#### MICHEL T. HALBOUTY OUTSTANDING LEADERSHIP AWARD

he Michel T. Halbouty Outstanding Leadership Award is given in recognition of outstanding and exceptional leadership in the petroleum geosciences. It is AAPG's second most distinguished award, second to the Sidney Powers Memorial Award. No more than one award is to be given per year.

#### Restrictions

The recipient does not need to be an AAPG member. The recipient must be living at the time of selection and be willing to be present to receive the award at the time and place designated by the Executive Committee, normally at the Annual Convention.

# Guidelines for Consideration of Candidates

Consideration should emphasize exceptional leadership demonstrated and extraordinary service given to the petroleum

geosciences and the Association. Candidates will have shown outstanding leadership and substantial service to the Association and petroleum geosciences as an elected official and/or through their substantial service on AAPG committees, or will have shown distinguished leadership in and remarkable service to the petroleum geosciences in a corporation or company, academic or research institution, or position of government. Past Presidency is not a prerequisite for this award. Honorary membership is not a prerequisite for consideration, but such membership is preferred for candidacy. Contributions may be in a variety of forms or combinations, such as demonstrated leadership in advancing the goals of the Association and/or the petroleum geosciences; articulated vision for future achievements of the Association and/or the petroleum geosciences; demonstrated leadership in the development and/or implementation of practical programs that enhance the benefits to members of Association and/or the petroleum geoscience community; demonstrated ability to lead the Association and/or petroleum geosciences to a major accomplishment or milestone; demonstrated leadership in the implementation of effective management strategies that serve to optimize the resources of the Association and/or the petroleum geosciences; and/or demonstrated leadership in the design and/or implementation of a sound business plan that maximizes the assets of the Association and/or petroleum geoscience community, while providing future opportunities to achieve major successes of the Association and/or petroleum geosciences, etc.

#### Procedure for Recommendation

Nominations for this award should be submitted, along with documentation, to the Chair of the Honors and Awards Committee at Association Headquarters. The Committee's recommendations will be submitted to the Advisory Council, which in turn will submit its selection to the Executive Committee for final action.

# **Description of Award**

The gold plated medal features a bas-relief likeness of Michel T. Halbouty and the name of the Association on the obverse side. On the reverse side are inscribed the words, "Awarded for Outstanding Leadership to the Petroleum Geosciences," along with the name of the recipient. The medal is mounted in multi-sided acrylic and is presented along with an embossed Certificate and lapel pin tack. Honorary membership is automatically bestowed upon recipients of the Award, if they have not already received that honor.

# History

This medal award was made a part of AAPG's honors by Executive Committee action in 1972. Initially it was a 5-inch solid brass medal mounted on a marble base. It was changed to a plaque-mounted medal award in 1984. In 1988 the name of the award was changed from the Human Needs Award to the Michel T. Halbouty Human Needs Award. In 2005 the name of the award was changed from the Michel T. Halbouty Human Needs Award to the Michel T. Halbouty Memorial Human Needs Award. The award name was changed to the Michel T. Halbouty Outstanding Leadership Award and amended by Executive Committee action in 2006.

# **Funding**

Funding for the award is provided through the AAPG Foundation Awards Fund through a generous contribution by Michel T. Halbouty.

#### HONORARY MEMBER

onorary Member is bestowed upon persons who have distinguished them-selves by their service and devotion to the science and profession of petroleum geology and to the Association. By Executive Committee action, this has been designated AAPG's third most distinguished award. It is customary, but not mandatory, to make one or more awards each year.

#### Restrictions

This honor is restricted to Association members.

# Guidelines for Consideration of Candidates

Candidates for Honorary Member Award should have distinguished themselves in service to petroleum geology and to the Association.

Contributions to the science and profession of petroleum geology may be in particular areas or combinations of discovery thinking, application, exploration leadership, research, etc.

Distinguished service to the petroleum industry may have brought favorable reflection on both the geologic profession and the Association.

#### Procedure for Recommendation

Nominations for this award should be submitted, along with documentation, to the

Chairman of the Honors and Awards Committee at Association Headquarters. The Committee's recommendations will be submitted to the Advisory Council, which in turn will submit its selection to the Executive Committee for final action.

### **Description of Award**

This award is a walnut chest. When opened, the right panel displays the AAPG emblem. Beneath the emblem is a plate bearing the recipient's name, the designation "AAPG Honorary Member," and the year awarded. The left panel has a plate bearing the signed citation.

# **History**

The award of Honorary Member was established in 1919. It was elevated to third honors position and given "medal" status by Executive Committee action in 1974. The medal bore the AAPG seal on the obverse side, with the recipient's name, the designation "AAPG Honorary Member," and the year awarded on the reverse side. It was worn on a neck ribbon assembly. In 1982, the Executive Committee approved changing the award to a walnut chest containing the appropriate presentation data.

# **Funding**

The AAPG provides funding for the Honorary Member Award.

# NORMAN H. FOSTER OUTSTANDING EXPLORER AWARD

The Norman H. Foster Outstanding Explorer Award is given in recognition of distinguished and outstanding achievement in exploration for petroleum or mineral resources, by members who have shown a consistent pattern of exploratory success, with an intended emphasis on recent discovery.

#### Restrictions

Recipient must be a Member of the Association; must be living at the time of selection; currently engaged in exploration and willing to be present to accept the award. Discovery may have occurred at any time in the nominee's career. The intended emphasis is on relatively recent discoveries (within the past 15 years). Only one award may be given per year.

# Guidelines for Consideration of Candidates

Candidates for the Norman H. Foster Outstanding Explorer Award shall be individual explorers or leaders of teams who have:

- discovered a significant petroleum or mineral resource, or
- caused a significant petroleum or mineral resource to be developed, or
- created a new significant play to be developed in a new or mature basin, or
- caused a new petroleum or mineral resource province to be opened up, or
- been a part of a team discovering a significant petroleum or mineral resource, or
- accomplished earth science exploration which can be demonstrated to be responsible for the discovery of a significant petroleum or mineral resource.

Recommendation for who should get the award:

- Individual for single discovery
- Leader of a group for single discovery
- Leader of a proven exploration team with significant discoveries
- Not be given to companies or organizations

The award may be shared by an **exploration team of individuals**, but shall not be given to companies or organizations. The "team" may be a multi-year team where original team members have gone on to other projects.

An explorer who causes a play to be developed or field to be discovered through the **use of new technology** will be eligible for the award. Consider only when there is a demonstrated direct connection between exploration/technology and a significant discovery by same explorer or team.

Present the award to the leader (or an outstanding member) of a team, who is an AAPG member and present a certificate to the rest of the team members acknowledging their contribution to the discovery. Consideration can be given (by the AC at the time of selection) as to what to do with the presence of a non-member. If the non-member is not a Petroleum Geologist it should not be a problem.

Many important resource development areas may have been previously drilled but may have been unrecognized or uneconomic or inaccessible for a variety of reasons. Thus, the award may be given for "rediscovering" and being the driving force in the development of these types of projects.

The term "significant discoveries" recognizes both relative and absolute size of a discovery. "Significant discoveries" in a mature basin may be large finds in the relative sense, whereas "significant discoveries" in an immature basin may be large in the absolute sense. In both cases, the discovery should affect what other explorers do in terms of where and how they explore. Examples are opening a new play or basin; developing/demonstrating the effectiveness of a new exploration technology; or demonstrating an original exploration strategy.

#### **Procedure for Recommendation**

Nominations for the Norman H. Foster Outstanding Explorer Award should be submitted, along with documentation, to the Chairman of the Honors and Awards Committee at Association Headquarters. The recommendations of the Committee will be submitted to the Advisory Council who will submit their selection to the Executive Committee for final action.

### **Description of Award**

The award will resemble a standing figure of a geologist on a base. The base will have a plate inscribed with the words, "Awarded for Outstanding Exploration", along with the name of the recipient. The award will be presented with a certificate describing the recipient's exploration successes.

Awards for team members will be a certificate with a likeness of the standing figure.

# History

The award was created in 2000, and amended in 2002, 2006 and 2008 by Executive Committee action. In 2011 the name of the award was changed from the Outstanding Explorer Award to the Norman H. Foster Outstanding Explorer Award.

# **Funding**

The AAPG provides funding for the Norman H. Foster Outstanding Explorer Award.

# ROBERT R. BERG OUTSTANDING RESEARCH AWARD

he Robert R. Berg Outstanding Research Award is given in recognition of a singular achievement in petroleum geoscience research. It is AAPG's fifth highest award, ranking beneath Norman H. Foster Outstanding Explorer Award and above the Distinguished Service Award. Up to two awards can be given in any calendar year.

#### Restrictions

The recipient does not need to be an AAPG member. The recipient must be living at the time of selection and be willing to be present to receive the award at the time and place designated by the Executive Committee, normally at the Annual Convention.

# Guidelines for Consideration of Candidates

Candidates for this award should have distinguished themselves with one or more advancements in the field of petroleum geoscience. The advancement(s) could be in the form of: proving, developing or advancing a theory; demonstrating a new approach to solving a problem; developing a new methodology or technology; application of existing theories, concepts, approaches, methodology or technology to increased exploration or production of hydrocarbon resources.

#### Procedure for Recommendation

Nominations for this award should be submitted, along with documentation, to the Chairman of the Honors and Awards Committee at Association Headquarters. The committee's recommendations will be submitted to the Advisory Council, which in turn will submit its selection to the Executive Committee for final action.

# **Description of Award**

This award is a plaque containing a sketch of Robert R. Berg along with the recipient's name and citation for distinguished contribution to advancement of petroleum geoscience.

# History

The award was established by Executive Committee action in 2006, and it was first awarded in 2008.

### **Funding**

Funding for the award is provided through the AAPG Foundation Awards Fund through generous contributions received by Robert R. Berg's many friends and colleagues.

### DISTINGUISHED SERVICE AWARD

he Distinguished Service Awardis presented to members who have distinguished themselves in singular and beneficial long-term service to AAPG.

#### Restrictions

More than one Member of the Association may be considered in any one year for this award, but Honorary Members should generally be excluded.

# Guidelines for Consideration of Candidates

The emphasis should be on long-term and, at the same time, *meaningful* service to the Association. The term *singular* does not necessarily mean *without precedent*, but rather that the activity be *specific* as distinguished from *general* service (such as membership on committees).

#### **Procedure for Recommendation**

Nominations for this award should be submitted, along with documentation, to the Chairman of the Honors and Awards Committee at Association Headquarters. The recommendations of the Committee will be submitted to the Advisory Council which will submit its selection to the Executive Committee for final action.

# **Description of Award**

This award is a walnut plaque with the AAPG emblem in brass and a brass plate bearing the recipient's name, the date, and citation.

# History

This award was established by Executive Committee action in 1971.

# **Funding**

The AAPG provides funding for the Distinguished Service Award.

# GROVER E. MURRAY MEMORIAL DISTINGUISHED EDUCATOR AWARD

he Grover E. Murray Memorial
Distinguished Educator Award is given in
recognition of distinguished and
outstanding contributions to geological education.
Only one award is to be given per year unless
funding is approved by the Executive Committee
when the award slate is approved. Contributions
leading to consideration for this award will most
often involve the teaching and counseling of
students at the university level, and contributions to
the education of the public, and management of
educational programs may also be recognized.

#### Restrictions

The recipient need not be a Member of the Association, and consideration is to be made without regard for national origin. The recipient must be living at the time of selection and be willing to be present to receive the award at the time and place designated by the Executive Committee. If death of the recipient occurs after selection, the medal will be awarded posthumously. The award is made at such times as the Executive Committee may designate, at the recommendation of the Advisory Council, but not more than once in any calendar year unless funding is also approved by the Executive Committee when it approves the award slate.

# Guidelines for Consideration of Candidates

Consideration should emphasize contributions to the teaching of students, guidance of student research, research and scientific publications, university and community activities, and involvement in the activities of scientific/professional organizations.

#### **Procedure for Recommendation**

Nominations for this award should be submitted, along with documentation, to the Chairman of the Honors and Awards Committee at Association Headquarters. All nominations become part of a permanent file for future consideration and need not be resubmitted, but additional information may be submitted at any time. The Committee's recommendations will be submitted to the Advisory Council, which in turn will submit its selection to the Executive Committee for final action.

### **Description of Award**

This award consists of an oak double shadow box. The right panel displays a sterling silver medallion specifically designed for this award. The double-faced medallion is removable and bears the name of the recipient and date of the award. The left panel displays an AAPG medallion and a plate containing the citation.

### History

This award was first proposed by Dr. Grover E. Murray in a letter to then President Harrison L. Townes, dated May 19, 1993. In the letter, Dr. and Mrs. Murray agreed to provide funding to support the award, if approved. Approval was given by the Executive Committee on June 30, 1993.

# **Funding**

Funding for the award is provided through the AAPG Foundation Awards Fund through a generous contribution by Dr. and Mrs. Grover Murray.

#### HARRISON SCHMITT AWARD

The Harrison Schmitt Award recognizes individuals or organizations that, for a variety of reasons, do not qualify for other Association honors or awards. The recipient is not required to be an AAPG member.

# **Examples of Past Awards**

Examples of such awards are those given to Conrad and Marcel Schlumberger (posthumously) for their development of the electrical log, to Harrison Schmitt for his contribution as the first geologist to land on the moon and study its geology, to John Bookout for "excellence in exploration leadership;" and to Norman Foster and Ted Beaumont for the "Treatise of Petroleum Geology."

#### **Procedure for Recommendation**

Nominations for this award should be submitted, along with documentation, to the Chairman of the Honors and Awards Committee at Association Headquarters. In the event that the Honors and Awards Committee and Advisory Council are not able to take action on the recommendation in a timely fashion, it will be referred directly to the Executive Committee of the Association for action.

# **Description of Award**

This award is a plaque with the AAPG medallion and a plate bearing the name of the award, recipient's name, the date and citation.

#### History

In 2011 the name of the award was changed from the Special Award to the Harrison Schmitt Award.

# **Funding**

The AAPG provides funding for the Harrison Schmitt Award.

#### PUBLIC SERVICE AWARD

he Public Service Award is given to recognize contributions by members of the Association to public affairs and to encourage geologists to take a more active part in such affairs. Granting of this award in any year is discretionary.

#### Restrictions

The recipient must be a Member of the Association, but may be in any class of membership. This award can be given without regard to previous awards.

Consideration should be restricted to those whose public service is above and beyond the framework of that person's normal job responsibility.

# Guidelines for Consideration of Candidates

Public affairs does not necessarily mean political action, but the activities may relate to areas of political concerns. Contributions are not limited to, but may commonly be in, education of the public, politicians, thought leaders, etc., on the application of geology to the general welfare. The field is not restricted to petroleum, but may be in land use, conservation of natural resources, etc.

#### **Procedure for Recommendation**

Nominations for this award should be submitted, along with documentation, to the Chairman of the Honors and Awards Committee at Association Headquarters. The recommendations of the Committee will be submitted to the Advisory Council which will submit its selection to the Executive Committee for final action.

### **Description of Award**

The award is a walnut plaque bearing the recipient's name, the date, and citation.

### History

This award was created in 1971 by Executive Committee action.

### **Funding**

The AAPG provides funding for the Public Service Award.

#### PIONEER AWARD

he Pioneer Award is given to longstanding members who have contributed to the Association and who have made meaningful and significant contributions to the science of geology and have not received other awards but are deserving of recognition.

#### Restrictions

The candidate must have been a Member of the Association for not less than 35 years (need not be contiguous membership) and be a member in good standing at the time of receipt of the award. The candidate shall **not** have received an award or be a current candidate for an award from the Association prior to receiving the Pioneer Award. The candidate must be living at the time of selection and, if at all possible, be present for the presentation of the award. If death of the recipient occurs after selection, the plaque will be awarded posthumously. No more than two awards shall be given each year. In addition, granting of this award in any year is discretionary.

#### **Procedure for Recommendation**

Nominations for this award should be submitted, along with proper documentation, to the Chairman of the Honors and Awards Committee at Association Headquarters. The Committee's recommendation will be submitted to the Advisory Council, which in turn will submit its selection to the Executive Committee for final action.

# **Description of Award**

This award consists of a plaque bearing the recipient's name, including the date and place to be presented with citation "long and valued service to AAPG".

#### History

This award was first proposed by the Advisory Council in 1996. Approval was given by the Executive Committee on October 2, 1996.

# **Funding**

Funding for the award is provided through the AAPG Foundation Awards Fund through a generous contribution in 1997 by Schlumberger Well Services.

# GEOSCIENCES IN THE MEDIA AWARD

he Geosciences in the Media Award is given to a person in recognition of notable journalistic achievement in any medium which contributes to public understanding of geology, energy resources, or the technology of oil and gas exploration. Granting of this award in any year is discretionary.

#### Restrictions

Whereas Members of the Association are not excluded, as a general rule it is expected that candidates would be professional journalists, writers, commentators, etc. It is also expected that writers for petroleum industry publications whose job it is to "contribute to the public understanding of geology, energy resources, or the technology of oil and gas exploration" would be excluded, unless there has been an extra effort that has been clearly beneficial by informing the general public.

# Guidelines for Consideration of Candidates

Because this field presents an extremely wide range both as to subject matter and as to possible geographic influence, it is difficult for a central committee to make clear and equitable judgments. Therefore, if at all possible, documentation as to the degree of improvement in public understanding would be quite important and useful. Moreover, inasmuch as this is an AAPG award, the implication is that the public influence should be at least regional in scope (i. e., several states). If the impact can be judged to have a "multiplying effect" beyond the immediate locality or region, this could be an important consideration.

#### **Procedure for Recommendation**

Nominations for this award should be submitted (with proper documentation) on or before June 1 of any year to the Chairman of the Honors and Awards Committee at Association Headquarters. The recommendations of the Committee will be submitted to the Advisory

Council who will submit their selection to the Executive Committee for final approval.

### **Description of Award**

The award is a walnut plaque bearing the words, "For notable journalistic achievement in communications contributing to public understanding of geology."

### History

The award was inaugurated in 1972 by Executive Committee action. In 2006 the name of the award was changed by Executive Committee action from the Journalism Award to the Geosciences in the Media Award.

# **Funding**

The AAPG provides funding for the Geosciences in the Media Award.

# YOUNG PROFESSIONAL EXEMPLARY SERVICE AWARD

he Young Professionals Exemplary Service Award is given to members who have promoted growth, awareness, and expanded opportunities within the organization for young professionals. The award will help recognize the importance of AAPG volunteers dedicating themselves to helping inspire, retain and recruit future geoscientists within the Association as well as to the organization and profession in general.

#### Restrictions

The recipient(s) must be a Member or Associate of the Association under the age of 35 and must be in good standing. More than one Member may be considered in any one year for this award.

# Guidelines for Consideration of Candidates

The emphasis should be on meaningful service to the Association by a young professional. The recipient(s) should have demonstrated excellence, enthusiastic participation, organizational creativity, leadership and passion for the activities of the Association.

The individual(s) must have served in a volunteer position within the organization for a minimum of three years, either at the local or national level. He/she must have assisted the YP Committee with their mission to aid the Association in expanding young professionals' outreach and opportunities within the

organization and/or industry including, but not limited to: retention of students, collaboration with the local societies to establish greater continuity between Student and YP chapters and the local affiliated society, recruitment of new members, appointments to committees and encouragement/guidance into leadership positions within AAPG.

#### Procedure for Recommendation

Members of the governing body of the Young Professionals Special Interest Group, as well as Section and Region leadership, will submit a minimum of five candidate recommendations (names and supporting biographical data/detail of volunteer efforts/accomplishment) to the chairman of the Honors and Awards Committee at Association headquarters by Feb. 1 of each year. Upon acceptance of the nominees, the H&A Committee will submit name(s) to the Advisory Council, which will in turn submit their endorsement to the Executive Committee for final approval.

#### **Description of Award**

Individual(s) chosen will receive an engraved crystal award, which will detail the name of the individual, name of award and the year presented. There shall be no cash distribution. The recipient(s) will also receive a framed certificate bearing the name of the recipient, title of the award and date presented. The award recipient will be invited to accept the crystal award in person at the Honors and Awards Ceremony held at the AAPG Annual Convention and Exhibition. The certificate will be mailed after the convention. Each award recipient's name and photograph will also appear in the Bulletin and annual convention program book.

#### History

This award was approved by Executive Committee action in 2015 and implemented in 2016.

# **Funding**

Funding for the award is to be provided by the AAPG.

# VLASTIMILA (VLASTA) DVOŘÁKOVÁ INTERNATIONAL AMBASSADOR SERVICE AWARD

The Vlastimila (Vlasta) Dvořáková International Ambassador Service Award is given to those who have promoted growth and awareness of the AAPG inter-nationally and created opportunities for the Association to reach a wider audience of geoscientists. This award will help recognize the importance of AAPG volunteers who promote the mission of services and products of the Association, who foster cooperation with other geoscience organizations, as well as growing the organization and its cultural and ethnical diversity.

#### Restrictions

The recipient must be a Member or Associate of the Association and must be in good standing. In exceptional cases, more than one candidate may be considered in any one year for this award.

# Guidelines for Consideration of Candidates

The emphasis should be on dedicated international service to the Association. The recipient should have demonstrated excellence, enthusiastic participation, organizational creativity, leadership, integrity, dedication and passion for the activities of the Association. They must have played a leadership role in promoting and organizing international events (ICE, Regional conferences, workshops and similar activities and initiatives), establishing greater connection and collaboration between the regional professional and academic societies and the Association thus aiding the Association in expanding its outreach and opportunities. These may include, but are not limited to; fostering relationships with industry based in the Regions, promotion, recruitment and retention of international students through dedicated events such Imperial Barrel Award event, young professionals and new members identify and promote appointments to committees and encouragement/guidance of member of Regions into global Leadership positions.

#### **Procedure for Recommendation**

Recommendations from both the general membership and Region Leadership are welcome. Nominators will submit candidate recommendations (names and supporting biographical data/detail of volunteer efforts/accomplishment) to the Chairman of the Honors and Awards Committee at Association

The certificate will be mailed after the convention. The award recipient's name and photograph will also appear in the Bulletin and Annual Convention program book.

### History

This award was approved by Executive Committee action in 2017.

# WALLACE E. PRATT MEMORIAL AWARD

he Wallace E. Pratt Memorial Award is to honor and reward the author(s) of the best AAPG *Bulletin* article published each calendar year.

#### Restrictions

The author(s) need not be a Member of the Association. If some of the material in the article has been published previously, there must have been substantive additional material in the *AAPG Bulletin* publication.

# Guidelines for Consideration of Candidates

The elected Editor will solicit recommendations from the Associate Editors; however, recommendations are welcome from all sources.

#### **Procedure for Recommendation**

Nomination forms, with publication reference of the article, should be submitted to the Editor before *March 1* following the year of publication. The Editor will forward his recommendations to the Chairman of the Honors and Awards Committee. Its recommendations are transmitted to the Advisory Council which will in turn transmit its selection to the Executive Committee for final action.

### **Description of Award**

The award is \$1,500.00 cashand a certificate bearing the recipient's name, the title of the award-winning article, and the appropriate bibliographical reference. Co-authors share equally.

### History

The Wallace E. Pratt Memorial Award was approved by Executive Committee action and the first award was made in 1982. The award was formerly a part of the President's Award.

The Wallace E. Pratt (1885-1981) was one of the world's most distinguished geologists. He was a founder of the Association, served as its fourth president and was the first recipient of the Sidney Powers Medal. He was also awarded AAPG's Human Needs Award and Honorary Membership. He was a Distinguished Lecturer, served on many committees, and remained a constructive adviser and inspiration all his life.

Dr. Amos Salvador, in his memorial to Pratt, said "But Wallace Pratt was not only a geologist; he was also a businessman, a scientist of broad interests, a humanist, a philosopher and a magnificent human being."

# **Funding**

Funding for the award is provided through the AAPG Foundation Awards Fund through a bequest from AAPG member Fred W. Bartlett (1897-1982).

# ROBERT H. DOTT, SR. MEMORIAL AWARD

he Robert H. Dott, Sr. Memorial Award is to honor and reward the author/editor of the best Special Publication dealing with geology published by the Association.

#### Restrictions

The author/editor need not be a Member of the Association. The preponderance of material in the book must not have been published before. Coauthors or co-editors will share in the award. Authors of individual papers in a compilation are not eligible unless involved as an editor or co-editor.

# Guidelines for Consideration of Candidates

All Special Publications published by the Association within the calendar year are considered for this award. The elected Editor will solicit recommendations from the Associate

Editors; however, recommendations are welcomed from all sources.

#### **Procedure for Recommendation**

Nominations should be submitted to the Editor on or before March 1 following the year of publication. The Editor will forward his recommendations to the Chairman of the Honors and Awards Committee. Its recommendations will be transmitted to the Advisory Council which will in turn transmit its selection to the Executive Committee for final approval.

# **Description of Award**

The award is \$500.00 cash and a certificate bearing the recipient's name and the title of the award-winning publication. Co-authors/coeditors share equally.

# History

The Robert H. Dott, Sr. Award was created by Executive Committee action to honor and reward authors of original articles dealing with petroleum geology published by the Association. The first award was made in 1945. In 1980, the award was expanded to recognize both the best *Bulletin* article and the best Special Publication. In 1982 it was changed to apply only to the best Special Publication. In 1988 the name was changed from the President's Award to the Robert H. Dott, Sr. Memorial Award.

# **Funding**

Funding for the award is provided through the AAPG Foundation Awards Fund through generous contributions from Robert H. Dott's many colleagues, friends and family as a lasting memorial.

# SEG/AAPG BEST PAPER IN INTERPRETATION JOURNAL AWARD

he SEG/AAPG Best Paper in Interpretation Award is to honor and award the author(s) of the best paper in the Journal Interpretation.

#### Restrictions

The author(s) need not be a Member of the Association.

# Guidelines for Consideration of Candidates

The voting will combine input from the SEG and AAPG membership at large, reviewers, and the editors of the journal. Criteria for the Best Paper in Interpretation would include the attributes of originality, innovation, potential impact, clarity, educational value, and overall significance to the practice of geoscience interpretation.

#### **Procedure for Recommendation**

Following publication of the November issue each year, the SEG and AAPG memberships will be encouraged to submit best-paper nominations from Interpretation issues of the year. The Editorin-Chief, Deputy Editor, Associate Editors, guest editors and reviewers will be asked to submit nominations during the normal course of review. Nominations received by 15 January from the SEG and AAPG membership and alleditors and reviewers will be entered into the final voting. In the final voting, the Editor-in-Chief, the Deputy Editor, and current Associate Editors will vote for their choice of the top five papers. Voting points will be tallied and the editors will affirm their selection. This recommendation will be forwarded to the SEG Honors and Awards Committee and the AAPG Advisory Council for final approval.

#### **Description of Award**

The recipient will be given two engraved plaques, one by AAPG and another by SEG and presented at the AAPG and SEG meetings. The plaques will not be identical. Co-authors will be mailed a certificate and will not be invited to accept their certificate at the annual meeting.

### **History**

The award was approved by the AAPG Executive Committee on May 18, 2013.

# **Funding**

The award will be funded as part of the joint journals annual expense with no cash award.

# J. C. "CAM" SPROULE MEMORIAL AWARD

he J. C. "Cam" Sproule Memorial Award is given to recognize and reward younger authors of papers applicable to petroleum geology.

#### Restrictions

The sole author, or lead author and recognized co-authors, do not need to be an AAPG member but must have been 35 years of age or younger at the time of submittal of the paper. The paper may have appeared in any publication of the Association, or that of an Affiliated Society, Section, Region, or Division. It must deal with petroleum geology.

The award has been given to the same author more than once (1993-94 and 2009-10). On several occasions, the award was given to teams of coauthors, all of whom were underage 35. In 2010, the award process was modified to allow consideration of lead authorsunder age 35 years, whose co-authors are overage 35 years. This is in recognition of the factthat a majority of AAPG publications consist of teams of multiple authors. In such cases, the co-authors over age 35 years would receive a Certificate of Appreciation, although the awardwould be to the recognized lead author underage 35 years. This was approved by Executive Committee action on September 26, 2009.

If the same *Bulletin* paper is voted to receive both the Sproule and Prattawards, that paper will

receive the Pratt award: the Sproule award will go to the paper receiving the second-highest number of votes.

An author may receive the Sproule award for a paper and the Dott award for a Special Publication in which the paper is published.

# Guidelines for Consideration of Candidates

Because eligible papers are published in the journals of Affiliated Societies, Sections, Regions, and Divisions as well as in the *Bulletin* and Special Publications of AAPG, it is imperative that editors of, and subscribers to, these journals assist the elected Editor of the Association in identifying outstanding papers for consideration. Since there are so many specialized fields pertinent to petroleum geology, the determination of eligibility of a particular paper may be difficult. In cases of uncertainty, this should be left to the Honors and Awards Committee.

#### Procedure for Recommendation

Nominations, together with copies or reprints of the papers and any other supporting data, should be submitted to the elected Editor before March 1 of the year following publication. Following a vote by the Associate Editors of the Bulletin, the elected Editor will submit his recommendations to the Chairman of the Honors and Awards Committee at Association Headquarters. Its recommendations will be submitted to the Advisory Council which willin turn submit its selection to the Executive Committee for final approval.

# **Description of Award**

The award is \$500.00 cash and a framed certificate bearing the name of the recipient, the title of the award-winning article, and the appropriate bibliographical reference. Coauthors under the age of 35 years share equallyin the cash award and will receive a framed certificate and invited to accept the certificate in person at the Honors and Awards ceremonyheld at the AAPG Annual Convention.

Co-authors over 35 years will not share the cash award and will receive by mail a Certificate of Appreciation. Co-authors over 35 years will not be invited to accept the certificate in person at the Honors and Awards Ceremonyheld at the AAPG Annual Convention. Co-authors over 35 years will be recognized as co-authors in the Bulletin and Annual Conventionprogram book by name and company.

# JOHN W. SHELTON SEARCH AND DISCOVERY AWARD

he John W. Shelton Search and Discovery Award is given at the Annual Convention of the Association each year in recognition of the best contribution to the "Search and Discovery" website in the past year.

#### Restrictions

The recipient need not be a Member of the Association. If some of the material in the contribution has been published previously, substantive additional material must be included in the Search and Discovery version.

# Guidelines for Consideration of Candidates

The award is to honor and reward the author(s) of a Search and Discovery contribution(s) considered to be the most outstanding.

The basis for determining the outstanding contribution to Search and Discovery is originality of concepts and/or techniques, applicability to, and impact on, exploration for and/or development of hydrocarbon resources and/or energy-mineral resources, clarity in presentation, and quality and added value of illustrative material.

#### **Procedure for Recommendation**

Nominations for the award come from members of the Search and Discovery Editorial Board and technical editors. The AAPG Elected Editor, Geoscience Director and Datapages Manager are also invited to participate in the nomination process. The Administrative Editor for Search and Discovery is responsible for both the nomination process and the final recommendation for the award to the Advisory Council.

# Description of the Award

The John W. Shelton Search and Discovery Award is \$1,000 cash and a certificate bearing the recipient's name, the title of the award-winning contribution and its appropriate web address. Co-authors share equally.

#### History

This award was established in 2009 to honor the creator and champion of the Search and Discovery website, John W. Shelton. With this online media AAPG is able to provide members worldwide with timely searchable technical papers. John W. Shelton is the originator and leader of AAPG's Internet publication program. He is considered the "father" of AAPG's Digital Library. From his vision and dedication many members benefit, and AAPG's global reach is greatly extended.

# **Funding**

Funding for this award is provided through the AAPG Foundation Awards Fund.

# GEORGE C. MATSON MEMORIAL AWARD

iven each year at the annual convention best AAPG paper presented the previous year at the annual convention.

#### Restrictions

The recipient of the George C. Matson Memorial Award is not required to be an AAPG Member. Selection of the winning paper is made only from among papers presented in AAPG Technical Sessions and AAPG Joint Technical Sessions at the annual meeting. Since a significant part of the scoring is based on quality of presentation, only the individual presenting the paper receives the award.

# Guidelines for Consideration of Candidates

The Matson Award Committee is an integral part of the AAPG Convention Committee structure, and its Chairman is appointed by the Convention General Chairman.

The Matson Award Committee Chairman chooses a group of judges who select the winning paper according to the quality of scientific content and excellence of presentation.

#### **Procedure**

The Committee's decision is conveyed by the Chairman to the Convention General Chairman as soon as possible following the convention. The General Chairman then informs the President of the Association who notifies the winner.

# **Description of Award**

The name of each recipient is engraved on the beautiful, large silver Matson Cup, which is retained at AAPG Headquarters. The recipient is given a plaque on which an engraved miniature replica of the silver cup is displayed. Co-authors will receive a certificate.

#### History

This award was established in 1957.

# **Funding**

Funding for the award is provided through the AAPG Foundation Awards Fund through a generous contribution of the Matson family as a lasting memorial to George C. Matson.

### JULES BRAUNSTEIN MEMORIAL AWARD

he Jules Braunstein Memorial Award is given each year at the annual convention of the Association in recognition of the best poster session paper presented the previous year at the annual convention.

#### Restrictions

The recipient of the Jules Braunstein Memorial Award is not required to be an AAPG Member. Selection of the winning poster session paper is made only from those poster sessions sponsored by AAPG.

# Guidelines for Consideration of Candidates

Judging is conducted by a Braunstein Award Committee to be appointed by the General Chairman of the convention and the Chairman of the Braunstein Award Committee. In the event of a tie in the total score, the paper scoring highest in "Originality: New concepts or new interpretations?" is declared the winner. In the event of a secondary tie at that level, the paper scoring highest on "Significance and usefulness" is declared the winner.

#### **Procedure**

The Committee's decision is conveyed by the Chairman to the Convention General Chairman as soon as possible following the convention. The General Chairman then informs the President of the Association who notifies the winner.

#### **Description of Award**

The Jules Braunstein Memorial Award is \$500.00 cash and a walnut plaque bearing the name of the winner and the title of the paper. Co-authors share the cash award equally, each receiving identical plaques.

#### **History**

This award is named in honor of Jules Braunstein whose contributions as an industry geologist, professor of geology, and an indefatigable worker for local, regional, and national geological organizations were outstanding. This award for the best poster session is especially appropriate in honor of Mr. Braunstein, since it was he who in 1975 recommended and arranged for the first poster sessions to be presented at the 1976 Annual Convention of the Association in New Orleans.

Mr. Braunstein proposed that the Association immediately establish a best paper award, but concern over the long-range success of poster sessions as a strong and viable part of the annual meetings led the Association to determine that a less formalized award called the General Chairman's Award be given and paid for out of convention funds until such time as poster sessions became established. Poster sessions were an immediate success, and now more poster session papers are given than are given orally in the more conventional manner.

Following Mr. Braunstein's death in 1983, many of his friends, especially in the Gulf Coast area, suggested that the Association formalize the poster session paper award and name it in his honor. This award was established in 1984 by the Executive Committee of the Association and the Trustees of the AAPG Foundation.

# **Funding**

Funding for the award is provided through the AAPG Foundation Awards Fund through a generous contribution from the Gulf Coast Association of Geological Societies as a lasting memorial to Jules Braunstein.

### A. I. LEVORSEN MEMORIAL AWARD

he A. I. Levorsen Memorial Award recognizes the best paper presented at each AAPG Section meeting, with particular emphasis on creative thinking toward new ideas in exploration. The award is made at the Section meetings for papers presented at the previous year's meetings.

#### Restrictions

The recipient need not be a Member of AAPG; selection is made from among all papers presented at a particular Section meeting. Since a significant part of the scoring is based on quality of presentation, only the individual presenting the paper receives the award.

# Guidelines for Consideration of Candidates

Each Section is responsible for establishing a judging committee to serve at the Section meeting. Papers are judged by this Committee according to creative thinking, organization, delivery, and visual aids.

#### **Procedure**

The selection of the judging committee is conveyed by the Section to Headquarters for preparation of the award.

# **Description of Award**

The award is a diamond shape crystal displaying the AAPG emblem and Section name. The crystal is mounted on a wood base with a gold plate inscribed with the recipient's name, year and name of the award winning paper.

# History

This award is perpetuated by the A. I. Levorsen Memorial Award Fund established in 1966 by Dr. Levorsen's friends, who wished to create a lasting memorial to him.

# **Funding**

Funding for the original award was provided through the AAPG Foundation Awards Fund through generous contributions from many of Dr. Levorsen's friends. In 2007, Dr. Levorsen's son, Robert Levorsen, provided a generous contribution to enhance and update the award through the AAPG Foundation Awards Fund as a lasting tribute to his father.

# GABRIEL DENGO MEMORIAL AWARD FOR BEST INTERNATIONAL PAPER

he Gabriel Dengo Memorial Award is given each year at the Annual convention in recognition of the best AAPG paper presented at the previous year's International conference.

#### Restrictions

The recipient of the Gabriel Dengo Memorial Award is not required to be an AAPG Member. Selection of the winning paper is made only from among papers presented during the International Conference & Exhibition.

# Guidelines for Consideration of Candidates

The chairman of the International Paper Award Committee is appointed by the General Chairman of the conference.

The chairman of the committee chooses a group of judges who select the winning paper according to the quality of scientific content and excellence of presentation.

#### **Procedure**

The Committee's decision is conveyed by the Chairman to the General Chairman as soon as possible following the meeting. The General Chairman then informs the President of the Association who notifies the winner.

# **Description of Award**

The recipient is given an engraved plaque with a miniature replica of a silver trophy cup, suitable for hanging on the wall. The name of each recipient is engraved on a silver trophy cup, donated by Pinar O. Yilmaz, which is retained at AAPG headquarters. Since a significant part of the scoring is based on quality of presentation, only the individual presenting the paper receives the award. Co-authors, if any, receive a certificate and are acknowledged in press releases announcing the winner.

# History

This award is given each year through the generosity of the Dengo family, in memory of Gabriel Dengo. Gabriel Dengo was one of the "gentlemen geologists" who became a geologist for the love of field geology, for mystery of the earth and to belong to an era of total devotion to

the science of geology. He was a role model to hundreds of young geologists and was a superb friend and associate to many.

Gabriel Dengo worked on Coast Ranges of Venezuela, including the geological study for the Caracas-La Guaira highway. He was among the first of Harry Hess' students working in Venezuela for what became the very successful Princeton Caribbean Research Program. After graduation, he returned to Venezuela to work for the Ministry of Energy and Mines, during which time he helped discover one of the largest iron deposits in the Guyana Shield.

Early in 1952, Gabriel returned to Costa Rica as field geologist for Union Oil Company of California, mapping mostly in the jungle. In 1956, the company moved him to Guatemala as resident geologist. In 1962, they transferred him to New Orleans as subsurface geologist. Because of his interest in Central America, Gabriel returned to Guatemala in 1962 to work for the General Secretariat for Central American Economic integration, where he was later appointed deputy secretary. In 1965, he transferred to the Central American Research Institute for Industry (ICAITI) to organize a geological research group. While in this position, he worked in several countries of Central and South America and in the Caribbean. Later he was appointed deputy director, and in 1975, director of ICAITI. He founded the Center for Geological Studies of Central America as a means to channel many of his scientific contributions.

This award was established as the International Paper Award in 1990 by Executive Committee action. The name of the award was changed to the Gabriel Dengo Memorial Award beginning with the 2001 award.

# **Funding**

Funding for the award is provided through the AAPG Foundation Awards Fund through a generous contribution by the Dengo Family as a lasting memorial to Gabriel Dengo.

# ZIAD BEYDOUN MEMORIAL AWARD FOR BEST INTERNATIONAL POSTER

he Ziad Beydoun Memorial Award is given each year at the annual convention in recognition of the best AAPG poster session paper presented at the previous year's International conference.

#### Restrictions

The recipient of the Ziad Beydoun Memorial Award is not required to be an AAPG Member. Selection of the winning poster session paper is made only from those poster sessions sponsored by AAPG.

# Guidelines for Consideration of Candidates

Judging is conducted by an International Poster Award Committee. The chairman is appointed by the General Chairman of the conference.

#### Procedure

The Committee's decision is conveyed by the Chairman to the General Chairman as soon as possible following the conference. The General Chairman then informs the President of the Association who notifies the winners.

# **Description of Award**

The Ziad Beydoun Memorial Award is \$500 cash and a walnut plaque bearing the name of the winner and the title of the poster. Co-authors share the cash award equally, each receiving a certificate mounted on walnut. The award will be presented at the annual convention.

# History

Ziad R. Beydoun was a prominent geologist in the Middle East and is largely responsible for surveying and mapping the region's rock successions. He spent his life in the field, mapping a vast region never before seen, mostly in the desert.

He was born in Beirut on Dec. 9, 1924, and initially was schooled in Palestine (Haifa and Jerusalem) and American University of Beirut; at the close of World War II he studied geology at St. Peter's College, Oxford.

After the demise of Palestine, his family fled to Lebanon, and he started working for Iraq Petroleum Company (the former Turkish Petroleum Company). He spent five years subsurface mapping in Lebanon, Syria, Iraq and the Gulf States, before shifting to field work in the Aden Protectorate (Yemen) as a geologist with the Hadramout Survey.

He joined Partex and participated in the discovery of oil in Oman by PDO. In 1963 he became a geological expert to the Lebanese Ministry of National Economy, and shortly thereafter joined American University of Beirut.

In 1970 he was appointed full professor and chairman of the geology department there, as well as special advisor to the Council for Scientific Research.

In 1985 he returned to London and joined Marathon Oil. He was appointed scientific director of a UNDP/World Bank project on the hydrocarbon study of the Red Sea/Gulf of Aden region, and at the invitation of the Yemeni government led the committee that pulled together the geology of Yemen, published as part of the International Lexicon of Stratigraphy.

He was an associate editor of the BULLETIN, and he authored over 50 articles and two books, including Arabian Plate Hydrocarbon Geology and Potential – A Plate Tectonic Approach, published by AAPG in 1991 in the Studies in Geology Series.

This award was established in 1990 as the International Poster Award by Executive Committee action. The name of the award was changed to the Ziad Beydoun Memorial Award with the 2001 award.

### **Funding**

Funding for the award is provided through the AAPG Foundation Awards Fund through generous contributions by Saudi Aramco Corporation, Pinar O. Yilmaz and Mrs. Muntaha Saghieh-Beydoun and many other friends and colleagues of Ziad R. Beydoun as a lasting memorial.

### BEST STUDENT PAPER AWARD

# **Description of Award**

The Carlos Walter M. Campos Memorial Award for Best International Student Paper is \$500 cash and a certificate.

# History

This award is named in honor of Carlos Walter Marinho Campos who was an outstanding contributor to petroleum geology of Brazil and for the continuous dedication in training geological professionals at Petrobras.

Carlos Walter Marinho Campos is one of the preeminent geologists from Brazil who was instrumental in training Petrobras geoscientists in petroleum geology. AAPG recognized his services to our industry with the Honorary Membership Award in 1992. Carlos Walter has continuously promoted participation of Brazilian geologists in international and domestic meetings and has been personally involved in training of geoscientists. He is credited with being personally responsible for encouraging 150 geologists to complete university-level degrees in Brazil and abroad. At the 1998 AAPG Rio meeting, Carlos Walter was given the Association of Brazil Petroleum Geologists Distinguished Geological Achievement Award

Carlos Walter was born in Barbacena, Minas Gerais. In 1952 he graduated from Ouro Preto School of Mines in mining metallurgy and civil engineering (B.A.). He completed his graduate studies at the Colorado School of Mines (Master's Degree of Science in 1958).

In 1958 he joined Petrobras and worked as head geologist in Reconcavo and Tucano basins in the former producing area of Bahia. In 1960he transferred to Belem as assistant district geologist, district geologist and superintendent of the area of North Exploration. In 1967 he was transferred to Rio de Ianeiro as assistant to the head superintendent of E&P department (Dexpro). He became director of exploration the same year, and general superintendent of Dexpro in 1977. During his tenure, the Garoupa field was discovered in Campos Basin (1974).

This was only the beginning of many important discoveries in Brazil - Pargo, Bagre, Badejo, Namorado, Cherne, Enchova, Bicudo, Bonito, Pampo and Corvina. The president of Brazil appointed Carlos Walter as Petrobras directorin 1979 with responsibilities of managing the recently formed exploration and drilling department and the

research center (Cenpes).

As director, he headed the innovative deep water exploration in the Campos basin, which resulted in giant petroleum discoveries like Albacora in 1984 and Marlim in 1985. Carlos Walter has an extensive list of internal Petrobras reports, covering the Medio Amazonas basins, Maranhao, Parana, Acre, South Tucaono and Reconcavo areas. Major contributions on economical issues for the estimation of the petroleum potential of the onshore Brazilian basins are also made by him.

Carlos Walter retired from Petrobras in 1985, and continued working with students at Brazil universities until his death in 1999. He was a member of the Brazilian Geological Society, Brazilian Association of Petroleum Geologists and the AAPG.

This award was established in June 2001 by the Executive Committee of the Association.

# Description of Award

The Ozan Sungurlu Memorial Award for the Best International Student Poster is \$500 cash and a certificate.

### History

This award is named in honor of Ozan Sungurlu, who was Vice President of Exploration at Turkish Petroleum Corporation and was instrumental with the affiliation of the Turkish Association of Petroleum Geologists with AAPG. Ozan Sungurlu was a role model to many young geologists, creating opportunities for them to get the international education and modern geological thought overseas.

Sungurlu was born in Gumushane, Turkey, in 1939 and completed his education in Eskisehir and Istanbul. After graduating from the Istanbul University in 1964, he started his career as field geologist at the Mineral Research Institute (MTA) and joined Turkish Petroleum Corporation (TPÅO) in 1969.

His interest in integrated geological processes started during his university education, where he became a researcher utilizing data and field relationships to question established dogmas for the geological problems in Turkey.

His extraordinary interest in fundamentals of geological thought drove him to solve the complex regional geology of Turkey, especially the events from the Mesozoic to Present.

He continued to be technically active, publishing on the structural geology and petroleum systems of southeast Turkey and regional geology of the Turkish portion of the Tethyan region. He also contributed greatly to the geological studies at both TPAO and Turkish academe, initiating collaborative field studies with Istanbul Technical University where he personally proposed studies on critical problems.

Sungurlu was a great supporter of AAPG, encouraging TPAO participation at international meetings, utilizing the AAPG Distinguished Lecture Program and encouraging affiliation of Turkish Petroleum Geologists with AAPG.

This award was established in January 2001 by the Executive Committee of the Association.
