INSTRUCTIONS TO THE APPLICANT:

Before making formal application for membership, read the qualifications printed below to assure that you are applying for the correct class of membership and that on this date you are fully eligible. You should also read the Constitution including the Code of Ethics and Bylaws. (These documents may be found at www.aapg.org or requested from Headquarters office.) Failure to inform yourself on these instruments will in no way excuse you from compliance with the requirements. You are requested to fill in all blanks in this form, or explain omissions. Information you give should be correct, leaving no room for doubt or misinterpretation.

Membership Qualifications (from Article I of the AAPG Bylaws)

Section 3. Active Members

Any person engaged in the practice or teaching of geology may apply for Active membership, provided the applicant holds a Bachelor's, Master's, or Doctor's Degree in geological science, including, but not limited to, geology, geophysics, earth science, geological engineering or environmental geoscience, from a college of acceptable academic standards and, in addition, has had a minimum of one (1) year of experience in the practice or teaching of geological science. The Executive Committee may waive degree requirements if in its judgement an applicant has adequate professional experience and has attained standing in the profession.

Section 7. Associate Members

Any person not qualified for any other class of membership who is a graduate of a college of acceptable academic standards whose employment is associated with geology, may apply for election as an Associate. The Executive Committee may waive degree requirements, if in its judgment an applicant has adequate professional experience, and has attained professional standing.

Application Requirements:

ACTIVE APPLICANTS

- Complete front page; sign and select appropriate level; remit dues and (one time) initial application fee.
- Complete Section 1
- Complete Section 2
- Complete Section 3 (Sponsors). Three sponsors are required for Active membership; two must be Active members of AAPG. The requirement for three sponsors is designed to preserve high professional standards and cannot be waived. Sponsors should be given the enclosed cards and instructed to complete, sign and return to AAPG directly.

ASSOCIATE APPLICANTS

- Complete front page; sign and select level; remit appropriate dues.
- Complete Section 1
- Complete Section 2

Current resume or vita may be attached in lieu of completion of Sections 1 & 2.

Payment of membership dues is required at the time of submission of the application and must be received before processing can begin. AAPG dues are based upon the member's ability to pay, i.e. their annual *Personal Gross Income* (PGI). No proof is required of any member's PGI. This system is honor based and defined by our standards of professional conduct.
