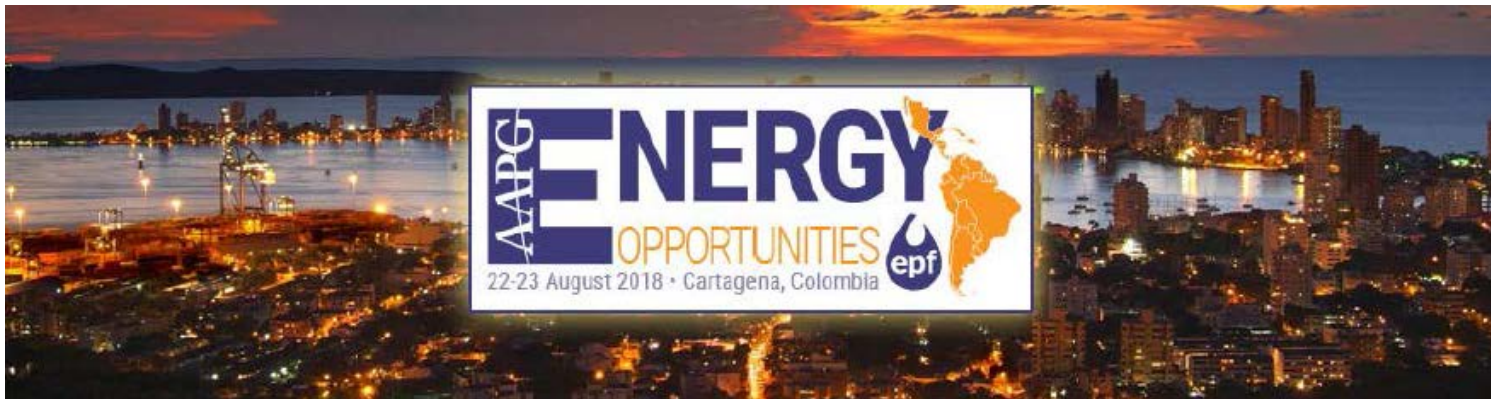

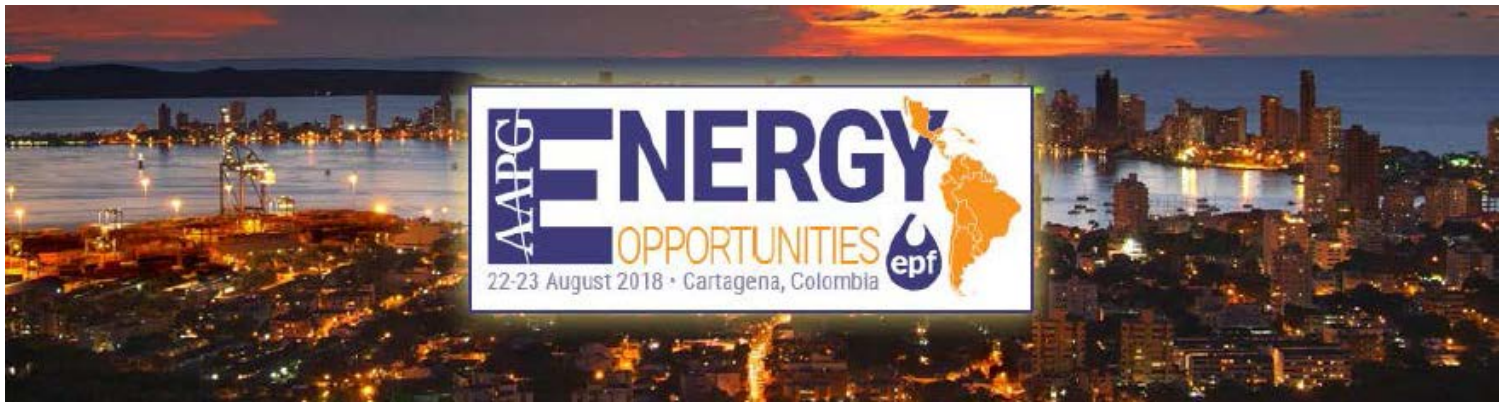

## SPONSORSHIP AGREEMENT TERMS & CONDITIONS

1. This Agreement shall be binding upon its acceptance as set forth on page 1 and per the terms listed below.
2. The (“Sponsor”) hereby submits the signed agreement (“Agreement”) for **Sponsorship of the 2018 Energy Opportunities Conference** of the American Association of Petroleum Geologists, a corporation (“AAPG”) to be held **22-23 August 2018 in Cartagena, de Indias, Colombia.**
3. Sponsorships are non-refundable and non-transferable.
4. All Sponsorship amounts are listed in U.S. dollars and must be paid in U.S. dollars.
5. Sponsorship monies paid to AAPG may be deductible as ordinary and necessary business expenses. They are not deductible as contributions or gifts for U.S. federal income tax purposes. AAPG is a 501(c)(6) membership organization; sponsorships paid to AAPG are not charitable donations.

The parties hereto hereby irrevocably submit to the person am jurisdiction and process of the Oklahoma District Court, Tulsa County, Oklahoma, United States of America, and agree that service by certified mail to their addresses shall constitute sufficient service of process.
