2020 SPONSORSHIP AGREEMENT

Terms and Conditions

1. This Agreement shall be binding upon its acceptance as set forth on page 1 and per the terms listed below.
2. The Sponsor hereby submits the signed agreement for Sponsorship at the 2020 Energy Opportunities Conference ("EOC") of the American Association of Petroleum Geologists, a corporation ("AAPG") to be held 23-24 September 2020.
3. Sponsorships are non-refundable and non-transferable.
4. Sponsorship fulfillment cannot be guaranteed unless Sponsorship is fully paid.
5. Sponsorships paid by 31 December 2019 receive a 10 percent discount off the total sponsorship amount.
6. The sponsorship payment schedule is as follows: **50 percent** of total sponsorship value is due 180 days prior to the event (**23 March 2020**); **50 percent** is due 90 days prior to the event (**23 June 2020**.)
7. Sponsorship commitments received after 23 June 2020 must be paid in full.
8. Sponsor hereby grants AAPG a non-exclusive license to use Sponsor Brand only in connection with advertising and promotion of the EOC. Any use of the Sponsor Brand shall be carried out pursuant to the instructions of Sponsor and AAPG shall be fully responsible for the fulfillment of these provisions. At the end of EOC, AAPG must return or destroy, as appropriate, the materials including Sponsor Brand, as well as refrain from using them, unless authorized by Sponsor. None of the statements set forth in this Agreement constitutes the assignment or transfer of any intellectual or industrial property rights held by Sponsor.
9. Exclusive sponsorships will be given priority over co-sponsorships.
10. Some items/events may not be available if the full amount of sponsor dollars requested is not reached. In this case, the current sponsors committed will be contacted with an opportunity to move contribution to another item/event.
11. Sponsors are required to submit an approved Company high resolution logo in JPEG, EPS, PDF or TIFF format with the signed Agreement.

18. This Agreement shall be governed by and construed and enforced in accordance with the laws of the State of Oklahoma, USA (without regard to any conflict of laws principles). All actions arising out of or in connection with this Agreement shall be brought in the Oklahoma District Court, Tulsa County, Oklahoma, USA which shall be the exclusive forum therefor. The parties hereto hereby irrevocably submit to the personam jurisdiction and process of the Oklahoma District Court, Tulsa County, Oklahoma, United States of America, and agree that service by certified mail to their addresses shall constitute sufficient service of process.
