1. All Sponsorship amounts are listed in U.S. dollars and must be paid in U.S. dollars. Sponsor rates exclude taxes.
2. This Agreement shall be binding upon its acceptance as set forth on page 1 and per the terms listed below.
3. The ("Sponsor") hereby submits the signed agreement ("Agreement") for Sponsorship at the **Energy Opportunities 2026 Conference** of the American Association of Petroleum Geologists, a corporation("AAPG") to be held 28-30 April 2026 in Rio de Janeiro, Brazil.
4. Sponsorships are non-refundable and non-transferable.
5. Sponsorship fulfillment cannot be guaranteed unless Sponsorship is fully paid. All sponsorships must be fully paid a minimum of 90 days prior to the event. If the contract is received within 90 days of the event, the invoice is due upon receipt.
6. Sponsor hereby grants AAPG a non-exclusive license to use Sponsor Brand only in connection with advertising and promotion of the **Energy Opportunities 2026 Conference**. Any use of the Sponsor Brand shall be carried out pursuant to the instructions of Sponsor and AAPG shall be fully responsible for the fulfillment of these provisions. 14. This Agreement shall be governed by and construed and enforced in accordance with the laws of the State of Oklahoma, USA (without regard to any conflict of laws principles). All actions arising out of or in connection with this Agreement shall be brought in the Oklahoma District Court, Tulsa County, Oklahoma, USA which shall be the exclusive forum, therefore. The parties hereto hereby irrevocably submit to the personam jurisdiction and process of the Oklahoma District Court, Tulsa County, Oklahoma, United States of America, and agree that service by certified mail to their addresses shall constitute sufficient service of process.
