Terms & Conditions

1. All amounts are in U.S. Dollars.
2. Sponsorships are non-refundable and non-transferable.
3. Sponsorship monies paid to AAPG may be deductible as ordinary and necessary business expenses. They are not deductible as contributions or gifts for U.S. federal income tax purposes. AAPG is a 501 (c)(6) membership organization; sponsorships paid to AAPG are not charitable donations.
4. The Sponsor must enclose a deposit of 50% of the total commitment as summarized on page one with final full payment to be invoiced in July 2018 unless otherwise noted by Sponsor or AAPG. Fulfillment cannot be guaranteed unless Sponsorship is fully paid.
5. Exclusive sponsorships will be given priority over co-sponsorships.
6. Some items/events may not be available if the full amount of sponsor dollars requested is not reached. In this case, the current sponsors committed will be contacted with an opportunity to move contribution to another item/event.
7. Companies and individuals donating less than \$1,000 will be acknowledged at the Patron Level.

All actions arising out of or in connection with this Agreement shall be brought in the Oklahoma District Court, Tulsa County, Oklahoma, USA which shall be the exclusive forum therefor. The parties hereto hereby irrevocably submit to the person am jurisdiction and process of the Oklahoma District Court, Tulsa County, Oklahoma, United States of America, and agree that service by certified mail to their addresses shall constitute sufficient service of process.
