- This Agreement shall be Binding upon its acceptance as set forth above.
- Sponsors who are also exhibitors will receive desktop easel signs to display inside booth during event.
- Exclusive sponsorships will be given priority over co-sponsorships.
- Some items/events may not be available if the full amount of sponsor dollars requested is not received.
