TERMS AND CONDITIONS:

- All amounts are in U.S. Dollars
- Sponsorships are non-refundable and non-transferable
- Sponsorship monies paid to URTeC may be deductible as ordinary and necessary business expenses. They are not deductible as contributions or gifts for U.S. federal income tax purposes
- A 50% deposit is required with a signed copy of this Agreement to guarantee secured sponsorship items. The remaining 50% will be invoiced and/or due no less than 60 days prior to the event dates. Complete fulfillment will not be guaranteed without full payment.
- This Agreement shall be binding upon its acceptance as set forth on both pages
- Exclusive sponsorships will be given priority over co-sponsorships
- Some items/events may not be available if the full amount of sponsor dollars is not received.
- Specific deadlines must be met for acknowledgement in printed materials:
 - Promotional Mailers (if necessary)
 - Event Program Brochure
- Sponsors are required to submit an approved logo in jpeg, tif or gif format along with URL address for website link and signed contract
- Sponsor shall defend, indemnify, and hold URTeC with supporting societies (SPE, AAPG, SEG) harmless from all liability, costs, and damages relating to acts and omissions of Sponsor and its employee's, agents, and contractors associated with the Event.
- If for any reason the Event is not held, URTeC may terminate this Agreement prior to the Event Start Date
- This Agreement contains the complete agreement of parties, and all prior agreements, whether verbal or written will be null and void
- This Agreement shall be governed by and construed and enforced in accordance with the laws of the State of Oklahoma, USA (without regard to any conflict of laws principles). All actions arising out of or in connection with this Agreement shall be brought in irrevocably submit to the person am jurisdiction and process of the Oklahoma District Court, Tulsa County, Oklahoma, United States of America, and agree that service by certified mail to their addresses shall constitute sufficient service of process.
