TERMS AND CONDITIONS

- 1. All Sponsorship amounts are listed in U.S. dollars and must be paid in U.S. dollars. Sponsor rates exclude taxes. Companies are responsible for determining if their local authorities withhold taxes on sponsorship payments and, if so, ensuring that AAPG receives the full amount due after taxes are withheld.
- 2. This Agreement shall be binding upon its acceptance as set forth on page 1 and per the terms listed below.
- 3. The ("Sponsor") hereby submits the signed agreement ("Agreement") for Sponsorship at the **Suriname Technical Symposium 2026: The Emergence of the Guiana Basin in Global Exploration, Development and Production** of the American Association of Petroleum Geologists, a corporation ("AAPG") to be held in 17-18 November 2026 in Paramaribo, Suriname.
- 4. Sponsorships are non-refundable and non-transferable. In the event AAPG cancels a sponsored item, the current sponsors will be contacted with an opportunity to move the contribution to another item/event.
- 5. Sponsorship fulfillment cannot be guaranteed unless sponsorship is fully paid. All sponsorships must be fully paid a minimum of 60 days prior to the event. If the contract is received within 60 days of the event, the invoice is due upon receipt.
- 6. Sponsor hereby grants AAPG a non-exclusive license to use Sponsor Brand only in connection with advertising and promotion of the **Suriname Technical Symposium 2026: The Emergence of the Guiana Basin in Global Exploration, Development and Production**. Any use of the Sponsor Brand shall be carried out pursuant to the instructions of Sponsor and AAPG shall be fully responsible for the fulfillment of these provisions. At the end of the workshop, AAPG must return or destroy, as appropriate, the materials including Sponsor Brand, as well as refrain from using them, unless authorized by Sponsor. None of the statements set forth in this Agreement constitutes the assignment or transfer of any intellectual or industrial property rights held by Sponsor.
- 7. Sponsors are required to submit an approved Company high resolution logo in vector (preferred) JPEG, EPS, PDF, or TIFF format with the signed Agreement. **Email logo to alopez@aapg.org.**
- 8. Specific deadlines must be met for acknowledgement in print materials.

- 9. All advertising materials and copy must be submitted and approved by **Suriname Technical Symposium 2026: The Emergence of the Guiana Basin in Global Exploration, Development and Production** Management in advance. Your sales rep will reach out with date the materials are due and submission instructions.
- 10. Sponsor represents and warrants that it and its affiliates own the Sponsor Brand and that AAPG's use of such marks in accordance with the terms of this Agreement shall not infringe on the rights of any third party.
- 11. AAPG acknowledges and agrees that Sponsor and its affiliates are the exclusive owners of all right, title and interest in and to the Sponsor Brand and that any goodwill derived through the use of Sponsor Brand by AAPG pursuant to the terms of this Agreement shall ensure the sole benefit of Sponsor and its affiliates. - 13. If for any reason the Event is not held, AAPG may terminate this Agreement prior to the Event start date.
- 14. This Agreement contains the complete agreement of the parties, and all prior agreements, whether verbal or written will be null and void.
- 15. This Agreement shall be governed by and construed and enforced in accordance with the laws of the State of Oklahoma, USA (without regard to any conflict of laws principles). All actions arising out of or in connection with this Agreement shall be brought in the Oklahoma District Court, Tulsa County, Oklahoma, USA which shall be the exclusive forum, therefore. The parties hereto hereby irrevocably submit to the personam jurisdiction and process of the Oklahoma District Court, Tulsa County, Oklahoma, United States of America, and agree that service by certified mail to their addresses shall constitute sufficient service of process.
