## TERMS AND CONDITIONS

1. All Sponsorship amounts are listed in U.S. dollars and must be paid in U.S. dollars. Sponsor rates exclude taxes. Companies are responsible for determining if their local authorities withhold taxes on sponsorship payments and, if so, ensuring that AAPG receives the full amount due after taxes are withheld.
2. This Agreement shall be binding upon its acceptance as set forth on page 1 and per the terms listed below.
3. The ("Sponsor") hereby submits the signed agreement ("Agreement") for Sponsorship at the **Venezuela Technical Symposium and E&P Summit 2026** of the American Association of Petroleum Geologists, a corporation ("AAPG") to be held 18-19 May 2026 in Houston, Texas.
4. Sponsorships are non-refundable and non-transferable. In the event AAPG cancels a sponsored item, the current sponsors will be contacted with an opportunity to move the contribution to another item/event.
5. Sponsorship fulfillment cannot be guaranteed unless sponsorship is fully paid. All sponsorships must be fully paid a minimum of 60 days prior to the event. If the contract is received within 60 days of the event, the invoice is due upon receipt.

8. Specific deadlines must be met for acknowledgement in print materials.
9. All advertising materials and copy must be submitted and approved by **Venezuela Technical Symposium and E&P Summit 2026** Management in advance. Your sales rep will reach out with date the materials are due and submission instructions.
10. Sponsor represents and warrants that it and its affiliates own the Sponsor Brand and that AAPG's use of such marks in accordance with the terms of this Agreement shall not infringe on the rights of any third party.
11. 15. This Agreement shall be governed by and construed and enforced in accordance with the laws of the State of Oklahoma, USA (without regard to any conflict of laws principles). All actions arising out of or in connection with this Agreement shall be brought in the Oklahoma District Court, Tulsa County, Oklahoma, USA which shall be the exclusive forum, therefore. The parties hereto hereby irrevocably submit to the personam jurisdiction and process of the Oklahoma District Court, Tulsa County, Oklahoma, United States of America, and agree that service by certified mail to their addresses shall constitute sufficient service of process.
